#### Areas of Applications

It can be applied on terrace, damp walls, ceilings, W/C bath water tanks, swimming pools, basements, foundation walls, all vertical surface etc.

#### Advantages

- o Good abrasion resistant
- o Excellent bonding properties

- o Prevents the carbonation in concrete

The applicable surface must be prepared by removing all loose plaster, joints must be sound & properly filled and cracks should be sealed with VS-WR-POLYMER. The surface should be free of oil, grease etc. Any uneven surface should be made even with 4-10% of VS-WR-POLYMER PMM on the basis Of cement content. When the surface is prepared properly apply the cement slurry as directed below.

VS-WR-POLYMER	25 Kg
Cement (OPC) / white	50 Kg
Water	Enough to be able to brush the Mixture

- Apply the slurry with help of a brush. Allow it to dry for about 30 60 mins. Application should be done when the atmospheric temperature is between 5°C and 35°C.
- 2. Before the second coat dampen the surface.
- 3. The thickness of the coating should be between 2mm and 4mm.
- 4. Subsequent coats may be applied even if the previous coat has not dried up.
- 5. The surface should be moist and protected from direct sunlight and extreme Temperature. Cover the surface with damp gunny bags for 3-5 days.

**Note**: For excellent performance polypropylene/polyester mesh can be incorporated in between the two coats & additional one coat is applied over the second one
